HqMOAA sends ... TRICARE Improves Coverage of Early Alzheimer's Treatment

TRICARE addressed a critical coverage gap by approving provisional coverage of a new type of drug for the treatment of early stage Alzheimer's disease – a move supported by MOAA and fellow key military and veterans groups.

For up to the next five years, TRICARE will cover Food and Drug Administration (FDA)approved monoclonal antibodies (MABs) lecanemab (brand name Leqembi) and donanemab (brand name Kisunla), for the treatment of Alzheimer's disease in patients with mild cognitive impairment or in the mild dementia stage of the disease. The assistant secretary of defense for health affairs approved the change last October.

Treatment for Alzheimer's disease is most effective when administered early – delays can result in irreversible disease progression – which made this prolonged TRICARE coverage gap particularly egregious.

VA to speed up health records system rollout

[Editor's note: No Washington, Idaho, or Oregon facilities are included] Veterans Affairs officials plan to rapidly accelerate the rollout of the department's new electronic health record system this year, adding 13 new sites to the deployment schedule in 2026. In December, department leaders had announced plans to resume deployment of the controversial Oracle Cerner system in mid-2026, with a few sites implementing training and software over the next 18 months.

The health records overhaul project, launched by President Donald Trump in 2017, was designed to bring veterans' health records in line with military files for the first time. The project was originally scheduled to take 10 years and cost \$16 billion. But nearly eight years later, only six of VA's 170plus medical sites are using the software.

"This has been a \$10 billion project that's not going anywhere," VA Secretary Doug Collins said. "So I'm pleased to announce right now that we're moving forward on a new plan that is going to bring by next year double or almost triple the number of hospitals online.

Staffers also complained to federal investigators about poor

training, frequent system outages and lackluster support programs. The total cost of the program has already reached \$16 billion, with outside advocates warning that figure could rise even higher.

Still, VA and Oracle officials testified to the House Veterans' Affairs Committee two weeks ago that they were confident the program was back on track. They expressed optimism about the mid-2026 rollout plan.

Collins' pledge comes as VA is reviewing its entire workforce organization, with a goal of reducing staffing by roughly 80,000 employees this year. Lawmakers on Capitol Hill have warned that trying to install the new records system without sufficient support staff could result in employee frustration and patient safety issues.
