# HqMOAA sends . . . Government Shutdown Impacts

#### **Retirees and Survivors**

(Note: this was current as of Oct 2)

- Armed services retirees, to include Coast Guard retirees, will continue to receive retiree pay during the funding lapse. Officers who retired from the U.S. Public Health Service or NOAA would not receive their next paycheck (Oct. 1 checks, covering pay from September, were processed).
- Commissaries and exchanges will remain open.
- Elective and routine medical procedures at military facilities may be canceled or postponed; contact your provider to confirm your appointment. The shutdown will not affect retirees using TRICARE or

TRICARE For Life benefits in the private sector.

- Military pharmacies will remain open, but hours may change.
- Survivor Benefit Plan payments will continue.
- Retirees and survivors covered under the Federal Employees Dental and Vision Insurance Program (FEDVIP) won't be affected. Federal employees whose FEDVIP premiums are deducted from their federal pay will retain coverage; their premiums will be deducted from retroactive pay when posted.

#### COLA 2026: Final Projection for the Annual Adjustment

Military retirees, Social Security recipients, and others receiving federal funds with a cost-of-living adjustment (COLA) should learn the amount of that increase for 2026 next week ... but a look at the figures so far gives a good indication where COLA will end up.

Should inflation trends continue, expect an adjustment between 2.7% and 2.8% for the coming year – outpacing this year's 2.5% figure, but below other recent annual increases of

3.2%, 8.7%, and 5.9%. This projection mirrors others made after the release of August's inflation figures, which showed a 2.8% yearly change in the Consumer Price Index for Wage Earners and Clerical Workers (CPI-W).

One important caveat: The Bureau of Labor Statistics has suspended operations, to include announcements and website updates, during the federal shutdown. The September CPI-W figure -- the final figure required for the 2026 calculations -- would not be announced Oct. 15 as scheduled if the funding lapse continues.

#### **TRICARE** Vaccinations

TRICARE For Life covers age-appropriate doses of vaccines based on the CDC's recommendations. A listed, covered vaccine, should be availablet at no cost.

However, vaccines needed for travel outside the U.S. – a yellow fever vaccination, for example – are not covered; you must pay out of pocket.

A personal note: my wife and I were unable to get yellow fever vaccinations for travel to Africa last year. I called the shot clinic at Fairchild AFB. They said to come on up. Got our shots, no hassle.
